Rives Township Regular Board Meeting 8682 Lansing Ave, Rives Junction MI 49277

March 31st, 2025

Board members present: Supervisor Jerald Adams, Clerk Joseph Super, Trustee Bryce Hammond, Treasurer Carol Schulz, Trustee Brandon Adams

Public hearing was called to order at 5:07PM.

Public Hearing

- Resident suggested that the \$6000 Deputy Clerk line item be used to partially cover the CPA contract that the Board has entered.

Q: Resident asked about a previous auditor bill of \$7,600 on top of the actual audit cost of \$16,000, and what was included in that?

A: That was for non-audit services including multiple journal entries that had to be corrected for the previous fiscal year and the one that the Board was currently in.

- Resident suggested that the revenue is still wrong and should be fixed before the budget is approved.
- FOIA Coordinator passed out a printed off copy of text messages between FOIA Coordinator, Deputy Clerk, and Supervisor and then discussed that the Deputy Clerk should not have the authority to use Clerk's email, and called for the remote access for the Clerk to be removed.

Q: Why is the board using a budget from today instead of using the same budget that was provided to residents through the week before?

A: Because the budget that the board has, and that the public was given at the start of this public hearing, does have additional expenditures added to it such as payroll that was ran this week.

- Resident thanked the board for "tolerating" the public and asked that the in-fighting on the Board stops immediately to allow everyone a chance to succeed.
- Resident stated that the board should remove the Clerk's "\$29,000 salary" and only allow the Clerk to sign paychecks.

Public hearing was closed at 5:21PM.

Meeting was called to order at 5:22PM.

Public Comment

- Resident stated that the animosity has to stop and that the board has to find a way to work together and give the Clerk a chance.
- Resident stated that the Clerk isn't doing his statutory duties and it's costing the Township money.
- Resident stated that in other industries if a person isn't doing their job they are terminated and that the Clerk is not doing his job.
- Resident stated that the posting for the special meeting doesn't state approving resolutions so the board should not be doing that during this meeting.
- FOIA Coordinator again spoke about text messages and claimed that a certain MCL law prohibits this type of behavior of the Clerk allowing the Deputy Clerk to send an email from his account.
- Deputy Clerk spoke about clearing up "rumors" in that the Clerk was busy/occupied but gave full permission to respond to the FOIA Coordinator during the conversation that was being discussed by the FOIA Coordinator previously. Deputy Clerk stated that she's doing the jobs that the Clerk tells her to do, and that that's well within the boundary of the laws regarding Deputies.
- Resident pointed out that the budget that was posted on the website was incorrectly posted so that it was "unreadable" to the public.
- Resident stated again that the Clerk should not give out passwords or allow authorization of the Deputy to correspond in such ways, and called for removal of remote access .
- Resident stated that while he has nothing personal against the Clerk, he feels that the Clerk and Deputy Clerk are being "hypocrites" because they wanted to take the job and then not do the work, and that now everyone is watching the Clerk "fail".
- Resident spoke about how things have gotten worse in the last few years with in-fighting on the board and that there is a pattern of "witch hunts" against at least one person on the board no matter who is on the board. Stated that the board needs to work together and end the fighting.
